DEVELOPMENT ACCOMMODATION REALIGNMENT STUDY



Scope

As part of the objectives of the realignment study, a preliminary layout of the proposed stream will be presented as for the path of the new stream. Cross sections that are designed to withstand a 500 cfs flow will be presented as possible stream bed designs. A recommended cross-section based on a hydraulic analysis is also expected. The state of Utah requires different levels of authorization to alter a natural stream. The requirements to obtain authorization vary depending on the type of alteration. The entities responsible of authorizing the realignment of Rose Creek are the US Army Corps of Engineers, the State of Utah, and the Salt Lake County. A detailed outline of the requirements to get authorization from these entities will be provided. Conceptual information on maintainable trail features will be proposed as possible ideas along the stream path. Other features such as a natural soil base or concrete base can be recommended in the realignment as well.

Deliverables will include a final report produced with the detailed outline for permitting requirements, a longitudinal and cross-sectional analysis, and other considerations. Additional monthly status reports documenting challenges, solutions & progress will be provided. Biweekly meetings will be held every Monday and Wednesday (and Friday as needed) until final report delivery in April.
